Auditor General for Wales' Audit Certificate and report

I report in respect of my audit of the accounts under section 13 of the Act, whether any matters that come to my attention give cause for concern that relevant legislation and regulatory requirements have not been met. My audit has been conducted in accordance with guidance issued by the Auditor General for Wales.

Auditor General's report

Audit opinion - Qualified

Except for the matters reported in my Basis for Qualification below, on the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's/Committee's governance arrangements; and
- that the Council/Committee does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis of qualification

Accounting Statement

In my opinion, the Council's Accounting Statement has not been prepared in accordance with proper practice. I am unable to conclude whether or not the Accounting Statement properly presents the Council's receipts and payments and financial position for the year.

- The value of fixed assets reported by the Council is understated and excludes a mover purchased for £5,260.

Annual Governance Statement

In my opinion, the Annual Governance Statement does not accurately report the Council's governance arrangements for 2020-21:

- Compliance with relevant laws: The Council asserts it took reasonable steps to ensure compliance with relevant laws. However, the Council has not provided its Clerk with a written contract or a written statement of the specified terms of employment as required under S.1 of the Employment Rights Act 1996 (ERA) within two months of starting employment.
- System of internal control: The Council asserts it maintained an adequate and effective system of internal control. However, the Council did not maintain an asset register to manage its assets.

Other matters arising and recommendations

Internal Audit report

In the Annual Governance Statement (AGS), the Council confirms that it has maintained an adequate system of internal control. An important source of evidence over the adequacy of the system of internal control is provided by the Internal Auditor. However, the Council did not receive the Internal Auditor's report until 3 days after it had approved the AGS.

We recommend that in future years, the Council ensures it has received and considered the Internal Audit report before it approves the AGS.

There are no further matters I wish to draw to the Council's attention.
